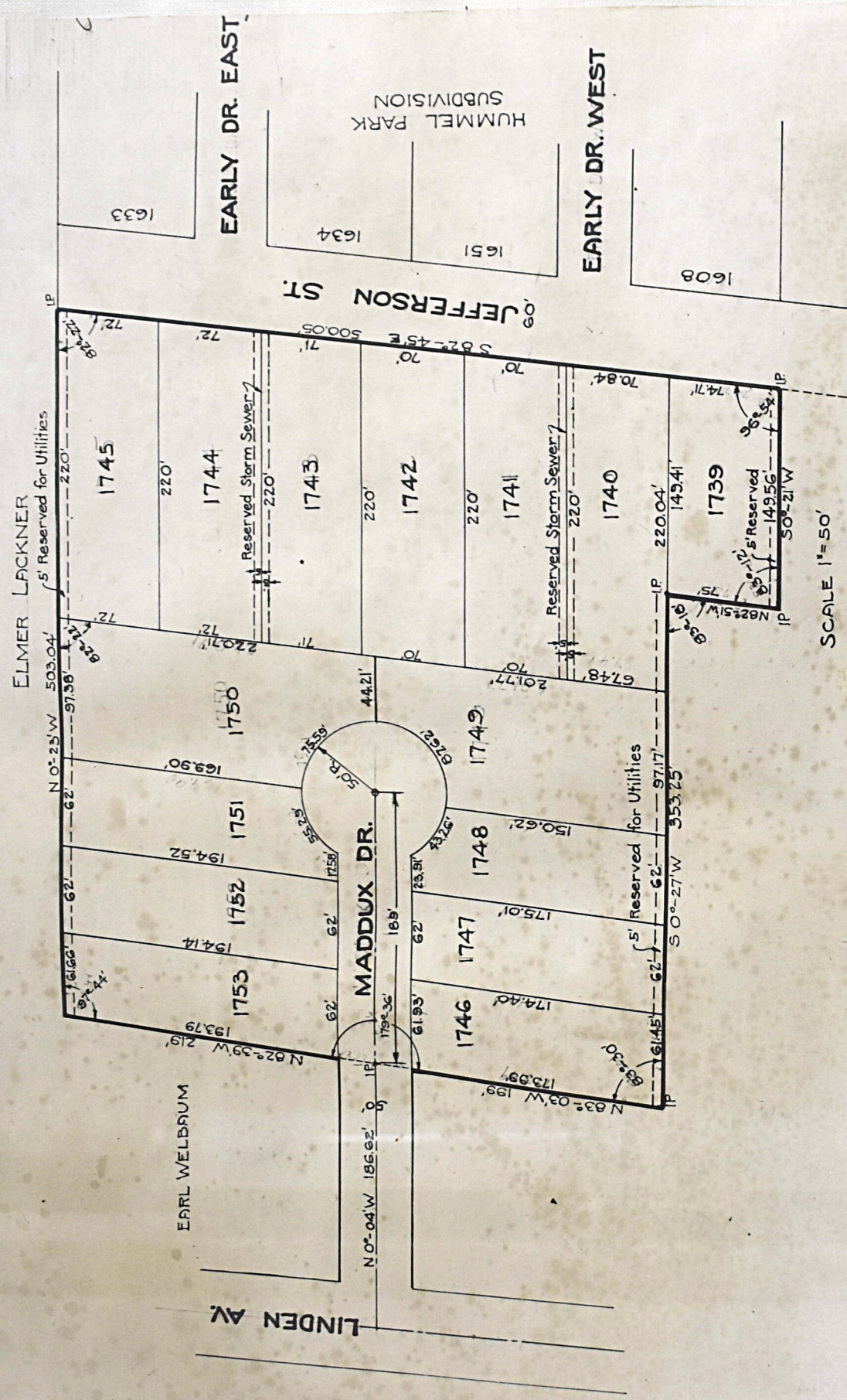


HUMMEL PARK PLAT ADDITION MIAMISBURG - OHIO

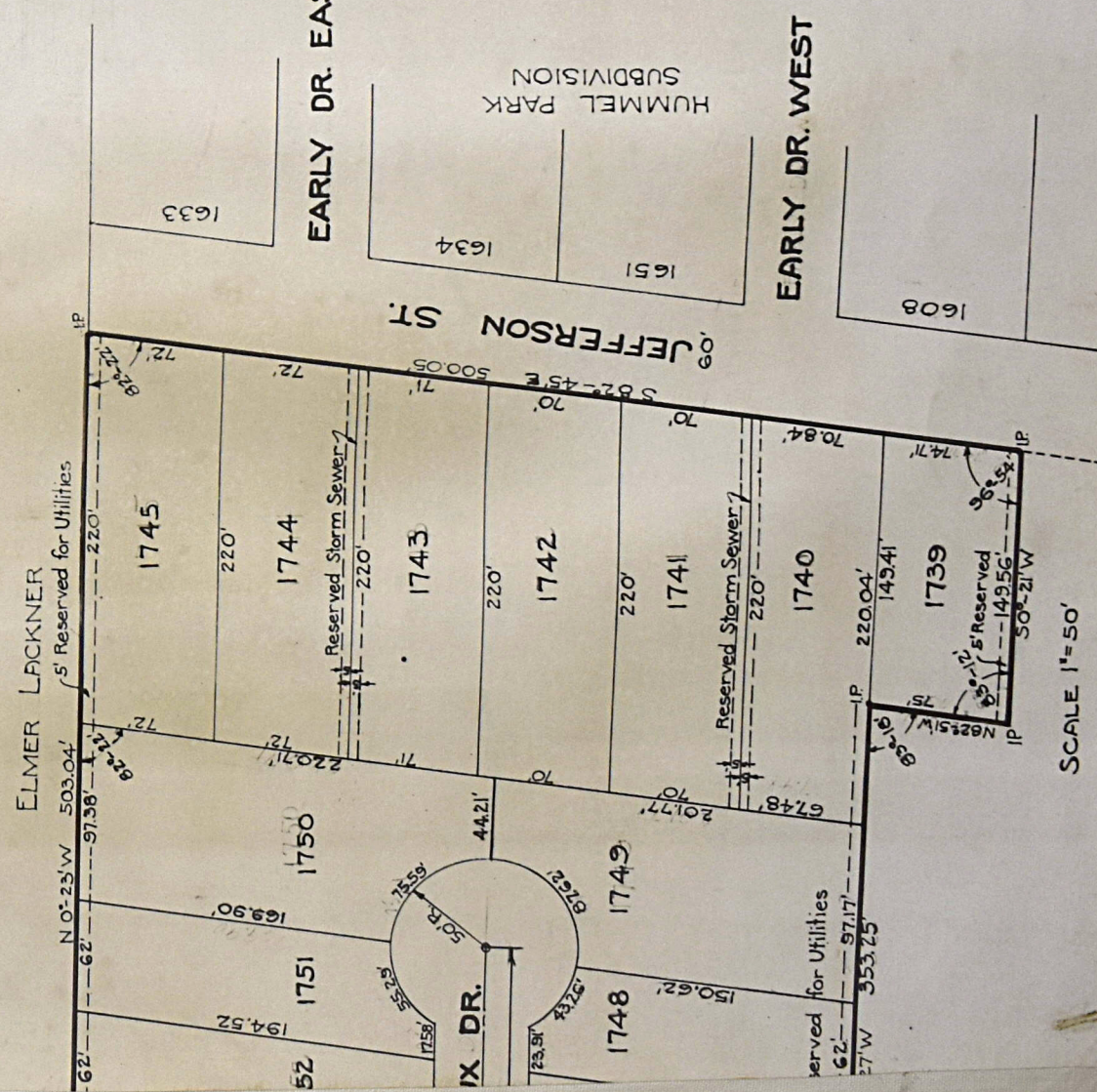
